Health and Safety

This section outlines the safety precautions associated with using Delphi Connect. The term “mobile device” will be used to refer to the Delphi Connect in this section.

Before operating your vehicle with your mobile device plugged in, please be aware of all the safety details.

DRIVING SAFETY

Remember that safety comes first when driving. If having the mobile device plugged in your vehicle interferes with your ability to access your vehicle’s pedals, or in any way prohibits you from properly operating your vehicle, do not drive with your mobile device plugged in. You can purchase an extension cable to move your mobile device

to a more fitting location. The extension cable can be purchased from U.S.Cellular at <https://uscellular.com>. If you discover while driving that you are not able to properly operate the vehicle with the mobile device plugged in, wait until you have safely pulled off the road and parked before attempting to remove the mobile device.

PRECAUTIONS

Your mobile device is a high quality piece of equipment. Before operating, read all instructions and cautionary markings. Failure to follow the directions below could result in serious bodily injury and/or property damage:

- DO NOT use this equipment in an extreme environment where high temperature or

- high humidity exists.
- DO NOT abuse the equipment. Avoid striking, shaking or shocking.
 - DO NOT expose this equipment to rain or spilled beverages.
 - DO NOT use unauthorized accessories.

GPS & AGPS

Your mobile device uses a Global Positioning System (GPS) signal for location-based applications. A GPS uses satellites controlled by the U.S. Government that are subject to changes implemented in accordance with the Department of Defense policy and the 2008 Federal Radio navigation Plan (FRP). Changes may affect the performance of the location-based services on your OBU. Your mobile device can also

use an Assisted Global Positioning System (AGPS), which obtains information from the cellular network to improve GPS performance. AGPS uses your wireless service provider's network and therefore airtime, data charges, and/or additional charges may apply in accordance with your service plan.

Location Information

Location-based information includes information that can be used to determine the approximate location of a mobile device. Mobile devices which are connected to a wireless network transmit location-based information. Additionally, if you use applications that require

location-based information, such applications transmit location-based information. The location-based information may be shared with third-parties, including your wireless service provider, applications providers, and other third-parties providing services.

FCC COMPLIANCE INFORMATION

This device complies with Part 15 of FCC Rules. Operation is subject to the following two conditions:

- (1) This device may not cause harmful interference, and
- (2) This device must accept any interference receive including interference that may cause undesired operation.

Warranty

12 MONTH LIMITED WARRANTY

Delphi Automotive Systems, LLC (the "Company") warrants to the original retail purchaser of this wireless device ("Product"), that should this Product or any part thereof during normal consumer usage and conditions, be proven defective in material or workmanship that results in the product's failure within the first twelve (12) month period from the date of purchase (proof of purchase required), such defect(s) will be repaired or replaced (with new or rebuilt parts) at the Company's option, without charge for parts or labor directly related to the defect(s).

This Warranty extends only to

consumers who purchase the product in the United States and it is not transferable or assignable.

This Warranty does not apply to:

- (a) Product subjected to abnormal use or conditions, accident, mishandling, neglect, unauthorized alteration, misuse, improper installation or repair or improper storage;
- (b) Product whose mechanical serial number or electronic serial number has been removed, altered or defaced;
- (c) Damage from exposure to moisture, humidity, excessive temperatures or extreme environmental conditions;
- (d) Damage resulting from connection to, or use of any accessory or other product not approved or authorized

by the Company;

- (e) Defects in appearance, cosmetic, decorative or structural items such as framing and non-operative parts;
- (f) Product damaged from external causes such as fire, flooding, dirt, sand, weather conditions, blown fuse, theft or improper usage of any electrical source;
- g) Product subjected to unauthorized modifications to the software of the Product or to the Product itself;
- (h) Product subjected to the unauthorized opening or repair of the Product;
- (i) Product subjected to hacking, password-mining, jail breaking, the unlocking of the boot loader using the fast

boot;
